- Please observe cart path rules and all signage.

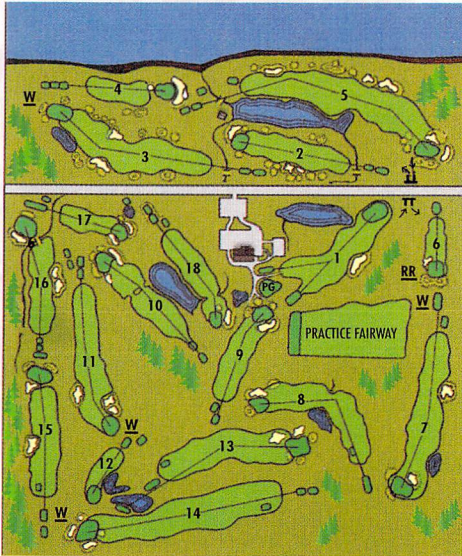
RCGA RULES GOVERN ALL PLAY

RED Stakes - Lateral Water Hazard

YELLOW Stakes - Water Hazard

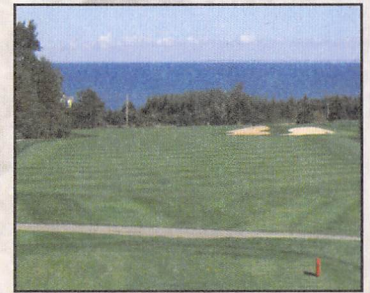
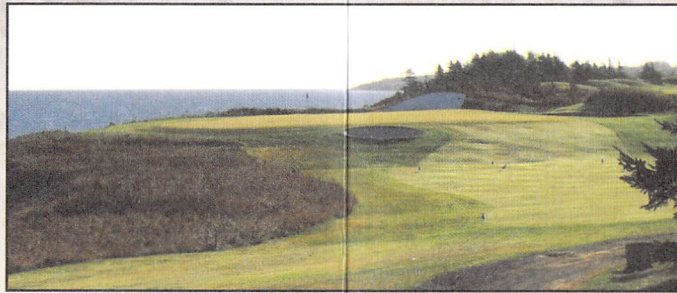
